Lake traffic starting to pick up as has our patrol

Has been some vandalism at the lake with broken windows.

Maintenance – Rick Kriegel

Reported: He and Stan Zeutenhorst drove roads to assess condition roads and measured for chip and seal Hauled rock on soft spots - swept rock out where snow was piled during winter road clearing

Took sander off the pickup - power washed it - greased it - put it away. =Also washed and put plow away Have been doing other general maintenance on all equipment

Found a wooden dock at Andy's Pond that floated away from a property. Owner can pick it up at the maintenance shop.

Reminded everyone if they can clean the leaves out of their ditches would really help the water flow with the spring rains.

Septic system installed at the campground. Siren is up and running and will be set off (tested) every Wednesday at noon unless the weather is bad.

Updates

1.RIZ, Mike Beumer reported on RIZ activities.

<u>Project #1605-North Boat Ramp</u>, clean out ditch, reseed and direct water through new culver to existing intake, seal coat the ramp. RIZ would like a variance to install a 60' culvert and share the cost with Holiday Lake approximately \$1,050.00.

Motion made by Phil Reeves to allow variance of culvert to 60' instead of 40', pay up to \$1,050.00 for chip and seal after work is completed. Seconded by Jim Hamilton. Motion passed by voice vote.

<u>Project #1602-AndysBoat Ramp</u>, re-grade and share the cost of chip and seal with Holiday Lake approximately \$500.00 to keep rock from washing into lake.

Motion made by Stan Zeutenhorst to pay up to \$500.00 for chip seal after work is completed. Seconded by Carla Bunger. Motion passed by voice vote.

<u>Project #1601-Delavue unit 2 lot 291</u>, clean out old sit pond and make it bigger by extending onto Holiday Lake owed property unit 2 lot 290, with no cost to Holiday Lake at this point.

Motion made by Phil Reeves to allow RIZ to extend the silt pond onto Holiday Lake owned property Unit 2 Lot 290, at no charge to Holiday Lake. Seconded by Stan Zeutenhorst. Motion passed by voice vote.

- 2. New Weather Siren, located in unit one is installed and working. Rick Kriegel and Jamie Hoffert will test the sirens every Wednesday at noon, unless there is a threat of severe weather.
- 3. July 2, 2016 Independence Day Celebrations, Email will be sent out along with placing on the website, volunteers are needed in many areas even to possibly assist with parking
- 4. Fish Signs No update, new signs can be changed easily to stay current with fish size and daily limits.
- 5. Guest Passes Board have had ongoing discussion since January 2016 on what if any changes are needed to regulate guest passes. At this time not changes to getting guest passes will be made. Reminder lot owners are responsible for people who are they are getting/giving a guest to. Phil Reeves noted that the rules have changed anyone fishing as a guest must be with the lot owner and/or with the immediate family of the lot owner. Also noted renters are not entitled to ownership rights, therefore, Holiday Lake property owners renting Holiday Lake properties are responsible for renters same as a guest renters have no rights to use Holiday Lake common grounds. Please report to the Holiday Lake Board of Directors is any renters are using the lake without the lot owner being present.
- 6. Beach Swim/Floating Platform replacement- Two new platforms have been ordered and will be placed far enough apart as to avoid anyone trying to jump from one to the other.
- 7. Equipment Durapatcher demonstration on Saturday, April 23. Tama/Toledo and the State of Iowa highly recommend it. It would patch small areas and would save money on cold-patch.
- 8. Water treatment-Connie Sjerven reported the temperature is 55.4 degrees and has raised 5 ½ degrees since Easter. At this time Andy's and Bozo will not be treated and monitored closely to see the success of treating the main lake. Connie Sjerven will check on weeds in Andy's and Bozo when testing the water.

Committee Reports

Community Center: No report

Fish: Rick Kalina reported Friday, April 15, 2016, Herman Brothers will be shocking (electrofishing) the fish to find out what kinds of fish are in the lake, size, weights, habitat, and water quality. Other bids were received with the cost of

\$3,000.00 but since they are going to be in the area the cost is \$750.00 and will be taken out of the fish fund. Any large grass carp will be removed there is not benefit to the lake when they reach maturity.

Water Quality: Connie Sjerven reported IA Water has always provided supplies to test the water but Connie has not received any yet and has been unable to get a hold of anyone.

D. Electrofishing

Motion was made by Phil Reeves to pay \$750.00 out of the fish fund for electrofishing to be done by Herman Brothers on Friday, April 15, 2016. Seconded by Stan Zeutenhorst. Motion passed by voice vote.

E. 2016 Bathhouse-Campgrounds/Park Restrooms – Park/Beach Manager

Bille Jean Snyder noted Lynn Baustian did a great job last year.

Motion was made by Stan Zeutenhorst to contract with Lynn for the 2016 season from April to October for the total of \$4,500.00. Seconded by Phil Reeves. Motion passed by voice vote.

F. Fuel Pump Quotes –

New electrical service from inside the building to the pole is needed to run the fuel pumps and bring yard light up to code. Ternus Electric quoted \$3,725.00, Collum Electric quoted \$2,341.80.

Motion was made by Stan Zeutenhorst to accept Collum Electric quote to replace electric wire from inside the building to the pole and bring yard light up to code with an LED and photo eye at a cost of \$2,341.80, TIP Electric will replace old pole with old pole from siren from unit one. Seconded by Phil Reeves. Motion passed by voice vote.

G. Display case -

Gary and Sheryl Edwards donated glass display case for engraved items for sale with the understanding it will be returned to them if it is no longer going to be used as a display case. To ensure it will be returned to the Edwards in the event that would happen, a note will be placed on the back of the case with their contact information if in the future the case is not required.
