The Poweshiek County Sheriff's Office has requested that all lot owners have a 911 sign. Not only are the signs helpful during an emergency, they can assist your family and friends in finding your lot. 911 signs can be purchased/ordered for \$25.00 each through the Holiday Lake Office during normal business hours.

**Composting of Yard Waste**

At the November 11, 2010 Holiday Lake Board Meeting it was announced a composting site will be provided for association members at the old brush pile, **due to a DNR ruling against open burning**. The composting site will be open every Saturday from 9:00 a.m. until 3:00 p.m. Composting began on April 30, 2011, and will continue through October 29, 2011. Materials accepted will be branches (no larger than 3" x 4') and any biodegradable yard waste (grass clippings and plant debris). This site will be monitored while open. When not open, the gate will be locked. **Any violations will be subject to a \$500 corporate assessment.** Volunteers are needed to monitor the compost pile. Anyone interested in helping, please contact the Holiday Lake Office during normal business hours.

**Roads**

On Thursday, April 14, 2011, the Holiday Lake Board of Directors voted to approve a quote from Manatt's to seal coat the entire route of Lakeshore Drive around the main lake, Windy Court, Echo Drive, Sunrise Drive, Skyline Drive, Shady Lane, Martin Drive, Tracy Drive, Holiday Lane, and East Ridge Drive. The funding for this effort is the result of the Supplemental Fee that lot owners voted to continue through 2011. The Supplemental Fee is for road improvements and/or maintenance related to the common areas of the lake.

### **Sale of Association Lots**

A decision was made by the Holiday Lake Board of Directors to sell some lots, which have come back to the Association. This will return those lots back to the tax base. A full listing will be available after September 1, 2011 on the website, at the Holiday Lake Office and on the event bulletin board.

### **2010 Boat Parade Grand Marshall Lorrenne Mulherin**

I am very honored, but I must admit, I find it a bit humorous, that at eighty three, I have been asked to be the Grand Marshall of the Holiday Lake 4th of July Boat Parade. On a very hot Sunday afternoon in August, 1962, my husband, Glen, and our two sons had just returned home from an enjoyable week at a lake in northwest Iowa. In our stack of mail was a flyer from Andy Wilson announcing the development of a man-made lake at Brooklyn, Iowa. We rather quickly decided to drive down and check it out.

It is still hard for me to believe, but we went home that day owning our lake lot. I say that because Glen and I were both cautious people and we realized that we may have just bought a lot for our "second home" before we owned our first. And, to make us question our sanity further, we only had the "hope" of lake water getting to our lot. We still believed we had made a good decision, but decided we wouldn't tell our parents or anyone else about it until the water got to the stakes on our lot. While waiting for the lake to fill, we had time to clear our lot and talk to contractors about building. Two winters later, we thanked God that Andy and the engineers knew what they were doing. The water was in front of our lot and had reached the stakes as we were told. Finally, we could tell our secret. It wasn't long before we had our cottage built.

Neither Glen nor I were boaters, so our first boat was a Jon boat. My dad loved to fish. Some of my fond memories were going down to the lake mid-week to fish with dad. The lake was beautiful. There were no boats to disturb it, only dad and I both fishing. Dad was bent on catching a big one and I perfectly content just to be there with him.

When we purchased the lake lot, we had two sons, Lynn, eight and Dennis, four. Two years later, John, was born. Lynn quickly learned how to operate the Jon boat, and Dennis and John were not far behind. It wasn't long before water skiing, and jet skiing looked good to them and this required the purchase of our Chrysler boat and motor and a jet ski. With our simple farm background, the delightful times we had at the lake seemed like a luxury but Glen chose to call it "cheap fun." Truly, it was one of our best investments. We had it all. I could work on my sun tan and swim all I wanted. The boys could swim, fish, boat, ski, or jet ski; and Glen, very quickly, became the expert at relaxing. There have been more than a few changes in my life. Eight years after we purchased our lot, we found and purchased the farm of our dreams. Our sons grew up, graduated from college and are married. We now have ten wonderful grandchildren. Almost fifty years have passed since we bought our lot here at the lake. The fun times we have had here are priceless. Glen passed away fifteen years ago, but the wonderful memories Glen and I had here will always be with me.

Our youngest son, John, takes care of our lot now for the rest of us. He has discovered what I already knew, that for some reason work around the lake just doesn't feel like work. I still love being here. Sorry to say, you won't see me skiing any more, but you may see me at the beach, play ground or in the boat. If you do please say hello!

**Voting Information:**

- Only lot owners who have paid all required fees by June 1st are eligible to be a director and/or vote.
- Lot owners may vote for each board position and any other business that comes before the membership, regardless of where your property is located.
- Only one vote per lot. SEE – Bylaws, Article IV Membership Section 1 for additional information.
- Partially owned lots are not entitled to a vote.
- Corporations, partnerships and any other association of individuals, including tenants in common, which purchase lots, shall designate, in writing, addressed to the Holiday Lake corporate secretary, the name of the person who shall exercise the entity's membership voting rights. Such notice must be signed by an authorized officer of the entity owning the lot or by each individual in the case of tenants in common owning the lot. If no written notice has been delivered to the Holiday Lake corporate secretary or if the person named is not present to vote, then a vote may not be cast.
- Absentee ballots will be available at the Holiday Lake Office beginning on Thursday, July 14, 2011, during normal business hours. The absentee ballot **deadline** is 5:00 p.m. CST on Friday, August 12, 2011. Please make note of the deadline for absentee voting. This is to allow the Holiday Lake Office and Nominating Committee ample time to get prepared for the 2011 Annual Meeting and to get the absentee ballots tabulated.
- No ballots will be issued at the Annual Meeting once the meeting has been called to order.

**PROPOSED SUPPLEMENTAL FEE PER LOT OWNER FOR  
A PERIOD ENDING WITH THE FEE ASSESSED ON APRIL 1, 2016**

The last two years the Holiday Lake Board of Directors voted to chip and seal some of the main roads to provide better access to the lot owners. This service reduces the amount of rock needed for the roads as well as making them easier to maintain.

To maintain the level of current services, which lot owners have come to expect, it is critical to maintain the current supplemental fee. The Holiday Lake Owners' Association Board of Directors proposes to either keep the rate of \$120.00 per lot owner for another five years, or increasing it to \$150.00 per lot owner for five years, making it possible to continue road improvements and/or maintenance related to the common areas of the lake.

*There will be a ballot with the above verbiage for lot owners to either vote to approve or disapprove the proposed annual supplemental fee per lot owner for a period ending with the fee assessed on April 1, 2016.*

Hi fellow fisherman, I would like to thank all of those that helped in the first annual Ice Fishing Derby and the volunteers that put some much needed fish habitat back in our water!!! The tree and pallet piles are a great addition to the yearly stocking regiment that the lake has been doing in the past years.

For those of you that have ventured out this year already, you might have noticed that the water is very clear (this makes for a little harder fishing). The fish are there but they are a little spooky (they can see and hear you) so when faced with these conditions, my recommendation is to down size your line and fish deeper. Our lake at this point has an over-abundance of 10-14 inch bass- these fish are the most aggressive and eat the most food in our waters. I personally went out several weekends ago and caught over 200 of these little missiles (and had a ball) but I also know that with this many mouths to feed in a body of water this size there is very little chance that there is a large population of bigger fish.

We have to consider our water as a delicate eco-system-and we have to be stewards of it-period. This spring -right after ice out- I had the pleasure to catch a 5 and 7 lb. bass in one afternoon on the lake-photos were taken and the girls were placed back in the lake-They were CPRed. What that means is that I Caught -Pictured-Released those fish. Now, I was raised to catch and release bass so that part is easy for me but in order to have a lake that has a potential of a number of these beauties there has to be many things go right for those fish to reach their potential. Without going into the science of it - We need several things to go right-1.Genetics-(those of you that deer hunt QDM) we want the fish with the best to survive. 2. Food Source-natural and supplemental (minnows or crawdads we put in) 3. Weather for spawning and oxygen levels. 4. Cover for smaller fish to grow. 5. Balance of big fish and little fish 6. A good system of harvest and catch and release.

Most of those things we do a good job of at Holiday Lake. The one that we need to work on is Selective harvest --as I stated earlier there is an over abundance of 10-14 inch bass in the lake - Some of these need to be harvested-the limit on keeping bass is 5 a day -so my recommendation to you is to keep 5 bass each time you go fish in that range. If you catch a bigger one CPR it and know that you are doing the lake a good thing. The other species will benefit such as the crappie (we have stocked a lot over the years but are not seeing the desired results) I truly feel that the bass population is eating most of the young crappie before they can mature. There does seem to be a nice population of walleye in the 13-16 inch range, as evident in the ice fishing tournament, and I have caught several this spring on a variety of lures. Hybrids and blue gills are there but those too are being reduced heavily by the sharks of the water (the little bass). There were a few perch caught this winter and I did manage one this spring so far (please let us know what you have been catching so we can monitor more closely). Restocking is only a part of the picture--please help by thinking about the future of the sport every time you catch a large fish (crappie,walleye,bass,catfish,perch) CPR it and who knows someone else might catch it and give them the thrill of a life time.

I would be glad to sit down with anyone and talk about the future of the fish at the lake as my mom always said-It takes a village to raise a child-It takes an association to raise a great fishing lake. We must work together! Brad Maus -Holiday Lake Fish Committee

**July 22, 2011** is the deadline for Voters Registration open until 5:00 pm at the Auditor’s Office.

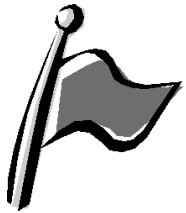
You may request an absentee ballot from the Poweshiek County Auditor, P.O. Box 57, Montezuma, IA 50171, 641-623-5443. Ballots must be postmarked by **August 1, 2011**, and received by the Auditor by **August 8, 2011**, for your vote to count.

Please note that only permanent residents of the Holiday Lake Subdivision can be a trustee or vote.

The Rural Improvement Zone allows the tax generated by improvements that increase the valuations to property within the Holiday Lake area to be set aside and used for improvements to the lake and the surrounding area for conservation (not for roads). The funds are requested and administered by a five-member Board of Trustees who are elected by full-time residents of the Holiday Lake Subdivision.

**Water Quality Committee (WQC):**

We have tested the water both in May and June and found oxygen, phosphates, chloride, bacteria and others well within the safe range. Chloride was higher than usual, but that seems to happen each spring. Our current committee includes Bill Vileta, Dan Hanover, Don VanVoorhees, Becky Payne, Kim & Larry Pendarvis and Connie Sjerven. If you would like to join us, we test starting at Bozo Fishing Lake at 9 am on the first Tuesday of the month. We’ve been attempting to meet the last Saturday of the month at Connie Sjerven’s resident, 5280 Buena Vista Dr. Please call Connie at 522-2300 if you would like to attend meetings.



**RED FLAG ALERT**

When a red flag is in place of the American Flag on the dam, and at the North and South boat Dock this is to signify that there is to be no wake due to high water.

**YELLOW FLAG ALERT**

When a Yellow flag is in place of the American Flag on the dam, and North and South boat dock this is to signify that Holiday Lake is experiencing high levels of Bacteria. Holiday Lake recommends not engaging in water activities.



**RECYCLE BIN**



The recycle bin is located at the office inside the fence and is available during normal business hours. (Please do not put your recycle items over the fence)

**Please do not place:** plastic bags, packing peanuts or trash/garbage (example: used paper towels) in the bin.

Also, glass needs to be clear, **no** colored glass please. If these items continue to be thrown in the recycle bin, we will have to consider discontinuing the recycle bin.

Bins are available for: metal, paper, magazines, **broken down cardboard** and number one and two plastics. (Please rinse or wash out cans, plastic and glass)

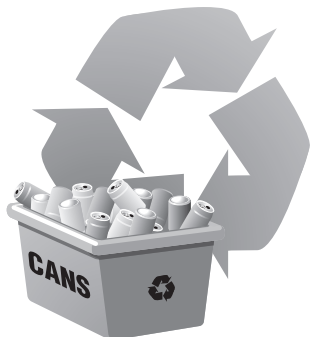
**POP CAN FUND**
